Host Schools:

- Up to two schools may partner to host one of the tournaments
- The Host Schools will be responsible for:
 - Coordinating team registration prior to the tournament
 - Submitting complete registration information to the Tournament Director on supplied spreadsheet template
 - Assisting with Tournament setup, operation, and tear down
- The host school will receive the entry fees as a donation to their club/school's program.

Entry Fees:

- The entry fee per school / club will be \$25 per 6 teams.

Participating Club Requirements:

- Each club must be a member of TBF or BASS with valid insurance coverage
- Each club will be responsible for maintaining permission slips and liability releases for each participant.
- Each participant over 16 year old must have a valid fishing license

2015 / 2016 PBC High School Tournament Trail

Points System:

- A 100 point system will be used for each tournament. First place will be awarded 100 points, second place 99, and so on. Teams participating but not weighing any fish will be awarded last place points.
- Season end team and school totals will be calculated on the best five out of six events.
- The “Team of the Year” will be awarded to the team with the most points in the season end total.
- School/club points will be accrued by adding the top three teams from each school for each tournament. Season totals will again be calculated based on the best five events.
- The “School of the Year” will be awarded to the school with the most points over the course of the season.

SC B.A.S.S Points:

- SC B.A.S.S. has endorsed these six tournaments as events for their BASS Nation High School Team Trail.
- Teams who compete in these events will earn points for the PBC High School Tournament Trail and the BASS Nation High School Team Trail at the same time.

Classic Qualification:

- Each school who participated in four of the six events may send a six angler, three boat, team to the two day classic event in May.
- The team will composed of the top three teams in points from the school

Tournament Rules:

1. Rules for this tournament follow the Youth Bass Fishing League Rules in the Handbook.
2. Boats must maintain a safe operating speed at all times. Violators will be disqualified.
3. All SC DNR fishing rules and regulations apply during tournaments, including fishing license and boating regulations.
4. Anglers must be age 11-18 and have registered roster and paid club dues. Anglers 11-14 years old will compete in a Jr. Division. Anglers 15-18 will compete in the High School Division.
5. All school rules apply during fishing tournaments.
6. The lake will be off limits beginning at 12:00 AM Monday of the week of the tournament, through safe light on Friday before the tournament. (Thursday for the two day classic)
7. Safety is the number one concern for these tournaments. All boats must be operated safely at all times. US Coast Guard approved PFD's must be worn at all times by student anglers and boat captains while the combustion engine is running. The boat must have an emergency ignition shut off device that is secured to the driver/captain's body. Boats must be covered by current liability insurance.
8. One captain over the age of 18 is required to be on each team's boat at all times during the tournament.
9. Tournaments will have a 5 fish per boat limit. All fish must be largemouth, spotted, redeye, or small mouth bass that are a minimum of 12 inches in length, unless the lake limit is longer, i.e. 14" on Murray and Greenwood. Teams should not possess more than 5 fish at any time during the tournament. Extra fish must be culled immediately on the water.
10. Dead fish cannot be culled. If a fish is foul hooked or accidentally killed, the fish must be kept and brought to weigh in as part of the fish limit. A 1/4 pound or 4 oz penalty for each dead fish will be assessed. This penalty will also apply to big fish.
11. All fish must be caught on artificial lures, and anglers may only use one rod at a time. Trolling is not permitted.
12. Every effort should be made to keep fish alive until they are released after weigh-in. All boats must be equipped with a properly working live well with aeration.
13. On Time/End of day check in:
 - a. Teams will be issued a numbered key float at registration on the morning of the tournament.
 - b. To be "checked in" in the afternoon, the key float must be turned in to the tournament trailed and displayed on the key board.
 - c. Boats that are late to weigh in will be assessed a penalty of 1 pound per minute after the designated check in time.
 - d. After 15 minutes, the team will be disqualified.
14. Tournament rankings will be based on total team weight.
15. If an emergency occurs, the captain or an angler should call 911 first, and then notify the tournament director. Any questions or concerns regarding these rules should be brought to the attention of the Tournament Director
16. Launch sequence will be determined by random draw at registration on the morning of the tournament. Any late registrants will be placed at the end of the take off sequence.
17. The violation of a tournament rule by either team member may result in weight loss, the loss of weight up to a particular time in the tournament day (eligible for a restart), loss of weight for the entire day, disqualification for the entire tournament or, in an extreme circumstance, ineligibility to participate in future events. If a team is disqualified from a tournament their weight will be recorded as 0 lb. However they will still receive tournament points as if they had just caught no fish. If the director feels that their violation was a willful attempt to gain an unfair

advantage or to intentionally cheat, then the director has the right to refuse entry from that team or team members in the future and will inform all members of the situation.

18. Interpretation of the rules will be left to the Director. Infractions of any rule may result in disqualification of catch. All decisions by the tournament director are final.
19. By signing the Official Entry Form, signing the sign in form at the ramp, and/or participation in these tournaments, I hereby release PBC Tournament Trails, LLC, its officers, sponsors, hosts, employees, and anyone working in association with them from any damages, injuries, or death that may occur as a result of competing in these events, whether by negligence of the said parties or otherwise to the fullest extent of the law

Tournament Operation & Officials:

- The tournaments will be operated by PBC Tournament Trails, LLC. on tournament day, and the necessary equipment for the tournament, including a tournament trailer, scales, PA system, weigh in tanks, etc. will be provided.
